#### 4. FIRST-AID MEASURES

#### **Inhalation**

#### **Uses and Restrictions**

PRO BLUE TABS with pro-active bacteria are suitable for use in all types of urinals, stainless steel, porcelain and ceramic troughs. Use in washrooms and restrooms with a history of odour problems, cleaning or pipe blockage problems. PRO BLUE TABS are wrapped in water soluble film, so no need to unwrap — the wrapper will dissolve with use in water. Place one wrapped PRO BLUE TAB in each urinal, or one every 50 cm in trough urinals. Replace when block has dissolved to maintain maximum efficiency. For optimal odour control around urinals and troughs, spray the surrounding surfaces with PRO-BLUE ODOUR DESTROYER and leave to dry.

## **User Information**

"PRO BLUE TABS" have been specially designed to clean and reduce odour problems associated with urinals. Each "PRO BLUE TAB" contains in excess of 3 billion pro-active bacteria (a species of 'probiotic' live bacteria) - they digest uric salts and sludge, uric deposits build-ups, eliminating the source of unpleasant odours rather than just masking them.
